PANELISTS

Barbara Swartz, Esq.

In addition to being THE HEALTH AND LAW SOCIETY'S faculty advisor, Barbara Swartz, Esq. has been a Professor of Law at Touro Law Center since 1982. She was formerly Associate Professor of Clinical Law at New York University Law School from 1973-1980. Barbara Swartz, Esq. is a Fulbright Scholar of the University of Copenhagen, Copenhagen, Denmark 1977-1978, and is a consultant for the World Health Organization. Barbara Swartz has a devoted interest in the area of health law. She has written many books involving health law issues and teaches LAW AND MEDICINE at Touro Law Center.

Lynn Paltrow, Esq.

Ms. Paltrow is an attorney for the American Civil Liberties Union, Reproductive Freedom Project. Her work involves issues of equality, privacy, freedom of speech and freedom of religion. She has handled cases including a lawsuit challenging Kentucky's mandatory parental consent law for minor women seeking abortions. Ms. Paltrow has been lead ACLU counsel in nationally recognized cases involving so called maternal-fetal rights conflicts; People v. Stewart, a case defending a pregnant woman charged with prenatal child abuse; In the Matter of A.C., challenging a court-ordered cesarean section that resulted in the death of both the woman and the infant; Jennifer Johnson v. State, appealing the conviction of a woman for delivering cocaine to a minor because she used cocaine during her pregnancy. Ms. Paltrow has also worked on most of the Supreme Court cases dealing with abortion including Webster v. Reproductive Health Services.
