# Resident Authors Book, 'The Right to Die'

At a recent Health and Law Society Luncheon, Elliott C. Winograd of Rockville Centre, counsel to the law firm of Newman Schlau Fitch Burns & Lane, P.C., of Mineola was the featured speaker reviewing his recent book, "The Right to Die: A Review of Current Status of New York Law: The Derivation of the Principles and the Ethical Considerations: A current Review of the Laws Throughout the United States."

At the luncheon, Mr. Winograd expressed his opinion that more individuals are drawn to the view that the ultimate horror is not death but the possibility of being maintained in limbo in a sterile room, by machines controlled by strangers. In his book, he defines under current New York State Law, various terms inherent to this subject matter. He also deals with whether or not there is a constitutional right to suicide; and concludes his book by saying, "Man does not possess absolute title to his life or to his body. Man is charged with preserving, dignifying and hallowing that life. The modern phrases 'quality of life' and 'quality of existence' embody within them a concept of worthiness
